




Find and involve 'local heroes' / champions (Miech et al., 2018; Taylor et al., 2015)


Inventory of skills they need, provide training (Raij, 2016; Rendón et al., 2005; Skinner et al., 2006)




Frequent / regular meetings (Sjölander & Scandurra, 2015; Skinner et al., 2006)




Define the role of each partner collaboratively (Bishop et al., 2003; Byrne & Sahay, 2007)



Find a common language for working together (Ferrario et al., 2016)




Involve local government to address issues at multiple levels (Kimaro & Twaakyondo, 2005)




Foster a positive and welcoming environment:




- Celebrating (smaller) milestones together (Hayes, 2014)



- Also invest in non-work activities (Ferrario et al., 2016)




- Facilitate pleasant environment (VanHeerwaarden et al., 2018)




- Be active and present in the environment (Hansen et al., 2008)

(Bishop et al., 2003; Byrne & Sahay, 2007; Rendón et al., 2005)


Establish a reference group with external experts (Berger & Peerson, 2009; Street et al., 2007; Trondsen & Sandaunet, 2009)






Open source, open access (Phanareth et al., 2017)
